Fall Leaf Collection



The Arlington Heights' Service Department offers leaf collection services to all Village residents during the autumn season. The department's goal is to provide efficient and effective leaf collection that is convenient for residents.

Demand and weather permitting, crews will collect leaves daily, Monday through Friday. The leaf collection program will begin on Monday, October 13 and continue through Friday, December 15. Additional time will be considered if leaves are late to fall this season. Remember, the same equipment used for leaf removal is needed for plowing and salting our streets. Leaves collected later in the season can also be placed in bags or containers for removal by Rumpke on the regular Tuesday curbside pickups.

Guidelines

- *All leaves must be raked into the right away, the area between the street and the sidewalk. Leaves in streets cause storm sewers to clog and create hazards.
- *Place leaves well away from obstructions such as trees, signs, fire hydrants and utility poles to allow for equipment to access and pick up leaves.
- *Do not include foreign materials, such as brush, twigs or grass clippings. Such material damages the leaf vacuum equipment.
- *Parked vehicles can obstruct access for equipment to pick up leaves; consider removing vehicles from the street when leaves are raked to the curb.

Remember: The burning of leaves is not permitted within the Village limits.

Recreational Fires

The Reading Fire Department desires all citizens not to be denied the enjoyment of recreational fires. Although these fires are typically small in size, they can still represent a significant fire hazard. In an effort to minimize damage and/or injury from fires, the Fire Prevention Code provides the following guidelines:

- When the fire is contained within an approved container (i.e. commercial fire pits, screened devices, etc.), the fire shall be located more than 15' from any structure. The immediate area within 15' should also be clean of combustible materials, such as overgrown brush, weeds, and shrubs.
- When the fire is not contained within an approved container, the fire should be located more than 25' from any structure and the immediate area within 25' clean of combustible materials.
- The burning of garbage, leaves, landscape waste, construction waste and other combustible materials are prohibited. Only seasoned, dried firewood is permitted.
- The fire must be started with combustible materials; no flammable/combustible liquids can be used to ignite the fire.
- The recreational fire must not exceed 3' diameter and 2' in height.
- The Fire Department may prohibit any burning when atmospheric or local conditions make such fires a hazard or nuisance.

Sign Board/Facilities Rentals



Our sign board is available to rent to display messages on a first come first served basis. The cost is \$8.00 per day. All Village business that needs to be posted has priority. The sign board is intended for Village-related public service announcements and for birthday, holiday, or celebrations. It is not intended for, nor will it be used for personal editorials or other general commentary. You can find the request form on our website.

Our Meeting Hall And Firefighters Park are also available to rent for Village residents.

The meeting hall is \$100.00 per day with a refundable \$50.00 deposit.

The park is \$25.00 per day with a refundable \$50.00 deposit.
